

## 25-2.2.2 Options and Transfers– Elementary and Secondary

---

Option and transfer forms are provided **in the most frequently spoken languages and** can be found at APS schools/programs, the central registration office and online. The forms are used when applying for

- Admission to an option school/program or
- **A transfer to another** neighborhood school that is **able to accepting** transfers, based on the Superintendent's annual update to the School Board.

The Superintendent's annual update to the School Board will be used to identify the number of seats available the following school year for

- Admissions to an option school/program, and
- ~~to identify which~~ Neighborhood schools **that** can accept transfers.

Some **neighborhood schools have option programs** ~~serve students within a neighborhood school~~. Students who are admitted to the program and choose to leave or do not continue to meet the program requirements must:

- Apply for a transfer to continue enrollment at the option school **outside of the program**, or
- ~~return to their neighborhood school.~~

**Admission to an option school/program or a transfer to a neighborhood school that is accepting transfers may be terminated if, in the opinion of the principal and after consultation with the Superintendent or his/her designee and the parents/guardians involved, it is creating a situation that is detrimental to the student and/or other students.**

### **TRANSFERS TO NEIGHBORHOOD SCHOOLS THAT ARE ACCEPTING TRANSFERS**

Neighborhood school transfers are available to the extent possible given financial constraints and capacity limits.

~~A transfer may be terminated if, in the opinion of the principal and after consultation with the Superintendent's designee and the parents/guardians involved, it is creating a situation that is detrimental to the student and/or other students.~~ **Moved above**

Transfers to neighborhood schools **that are accepting transfers** must be consistent with the **Application and Admissions Process** below, and must take place before the beginning of a given school year. The Superintendent/designee must approve exceptions. High school students granted such an exception may not be eligible to participate in activities governed by the Virginia High School League for the remainder of that school year.

The following tables identify all APS option schools/programs, and each requires an application as defined in the "Application and Admissions Process ~~for Option Schools/Programs~~" section.

**APPLICATION AND ADMISSIONS PROCESS**

**Application Process**

To help families make informed decisions, the parents/guardians of the applicant are encouraged to visit, during school hours, both their neighborhood school and the ~~option~~ school/program to which they are applying. Schools/programs offer scheduled informational meetings or, when needed, families can work with the principals to schedule an appointment.

All applications for **admission to an option school/program or transfers to a** neighborhood school **that is accepting** transfers ~~are~~ ~~and option school/program admissions~~

- ~~are~~ Submitted to the central registration office, which is responsible for managing and processing all ~~neighborhood school transfers and option schools/program~~ applications, lotteries, notifications and waitlists.

~~Applications for transfer to a neighborhood school that is accepting transfers or admission to option schools/programs~~

- ~~are~~ Due by level on the following days
  - Secondary – by the third Friday in January, by 4 p.m.
  - Elementary – by April 15 (Note: If April 15 falls on a weekend or school holiday, the deadline is extended to the next instructional day for students).

**Lotteries**

When the number of applications ~~for an option school/program~~ exceeds the available seats, the central registration office will conduct a random double-blind lottery to determine admission for available slots.

**Preschool and sibling applicants will be accepted in accordance with the policy. A lottery will be conducted for all other applicants to fill the number of slots identified in the Superintendent's annual update.**

Lotteries will be conducted in the same manner, with some exceptions, as defined below.

**Elementary Immersion Lotteries** - will separate applicants into pools of English language speakers and Spanish language speakers based on information available at registration. This lottery is designed to support a balance of English and Spanish language speakers.

**Secondary Lotteries** – **will separate applicants into pools based on the neighborhood school attendance zone in which they reside. An allotment of slots is allocated to a neighborhood attendance zone based on the proportion of students in that zone for the countywide grade level cohort:**

- **Grade 5 for middle school/program lotteries**
- **Grade 8 for high school/program lotteries**

**Students enrolling in APS who are currently attending private schools or identified as home-**

schoolers will apply based on the neighborhood school attendance zone in which they reside.

**Notification of Admissions**

The central registration office will notify families of the status of admission to the option schools/programs **or to the a** neighborhood school **that is accepting** transfers.

**Waitlist**

The lottery will **also** be used to determine the order for admitting additional students **applications not admitted through the lottery**. Each application for admission submitted after the stated deadlines will be placed **at the end of the on a** waiting list, **in the order received**, if the requested school/program does not have vacancies.
