SUBJECT: Framework for Proposed Refinements to High School Attendance Zone

Boundaries

DATE: September 8, 2016

At the August 30, 2016 School Board Work Session the School Board requested that staff develop a plan to engage in a high school boundary adjustment process in Fall 2016.

School Board Policy 30-2.2 Boundaries states that, "when the Superintendent has determined ... that boundary changes should be considered, the Superintendent shall recommend to the School Board the process for consideration of boundary changes. The recommended framework shall include the proposed schedule for the boundary change process, identification of the schools and communities to be affected, and an outline of the process to include affected schools and communities in the consideration of boundary changes. The School Board shall act on the recommendation."

A communication plan and an online boundary tool will be developed for this process. After the engagement process and online boundary tool have closed, staff will analyze all options submitted. Based on the criteria in School Board Policy 30-2.2 Boundaries, staff will make a recommendation to the Superintendent. The Superintendent will make a recommendation to the School Board for information and action. The School Board will hold a public hearing to receive additional community input.

The School Board will act on boundary recommendations in December 2016 prior to High School Information Night on December 12, 2016 for rising freshman. The boundary adjustments will take effect in Fall, 2017 and will begin with 2016 eighth graders who will be ninth graders in 2017, and will continue with future incoming freshmen. In addition, the recommendations will include options for sibling considerations and transportation services. No current high school students will be affected by the proposed boundary refinements.
