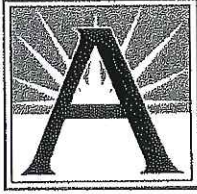

Remove paragraph 6. CONTRACT TERM from EXHIBIT E – General Terms and Conditions to Contract # 73FY16 and replace with the following:

6. **CONTRACT TERM**
Time is of the essence. The Contract Term shall commence on the date the Purchasing Agent fully executes the Contract and shall terminate on August 31, 2017. The Contract may be renewed, one year at a time, by APS in its sole discretion at any time prior to thirty (30) days following expiration of the latest Contract Term, and such Renewal Contract Term shall be effective immediately upon expiration of the latest prior Contract Term. APS shall have this right of renewal for up to but not more than four (4) Renewal Contract Terms, making a maximum of five (5) Contract Terms.

By mutual agreement, Contract #73FY16 is renewed for one (1) year at existing terms and conditions. The renewal shall be effective from September 1, 2017, and shall remain valid through August 31, 2018. All other terms and conditions shall remain unchanged.
