Within five days of the date the agreement is signed by Arlington Public Schools; you are requested to furnish a Certificate of Insurance as outlined in Section #65 of the IFB.


Contract period is September 1, 2015 – September 30, 2020 with four (4) additional one-year periods at the same terms and conditions.
