Friday, November 13	<ul style="list-style-type: none">• Deadline: November 13: Students submit video in Part II: APS Visual and Performing Arts Governor's School Information 2020 - 2021• Students use guidelines for adjudication information for each area - see pages 17 - 21 in General Information for Students and Parents

Thursday, November 12 - Tuesday, November 24	<ul style="list-style-type: none">• Interviews scheduled for each specialty area
By Tuesday, December 1	<ul style="list-style-type: none">• APS notifies VDOE of selected candidates to send forward for state adjudication based on quota• Students moving on to the state level adjudications should contact two adults (one current teacher/one other adult) to write recommendations
By December 4	<ul style="list-style-type: none">• APS notifies students selected and not selected as candidates to send forward to VPA VDOE adjudication based on quota
Monday, December 14	<ul style="list-style-type: none">• Deadline for students to share conflicts with state adjudication dates (Friday, January 8 in PM; Saturday, January 9)
By Tuesday, December 15	<ul style="list-style-type: none">• VDOE adjudication schedules emailed to each school division<ul style="list-style-type: none">o Any changes to adjudication schedule after December 15 results in a \$25 charge

Mid-February	<ul style="list-style-type: none"> • APS Summer Residential Governor's School Committee meets to review multiple criteria and select nominees to send forward to VDOE
By February 26	<ul style="list-style-type: none"> • Gifted Services deadline to complete electronic nomination form and send applications to VDOE
Beginning of March	<ul style="list-style-type: none"> • APS notifies students selected and not selected as nominees to send forward to VDOE based on state quota
End of April	<ul style="list-style-type: none"> • VDOE notifies each nominee of admission status
