This Amendment No. 1 (hereafter "Amendment"), by and between Arlington County School Board, operating as Arlington School Board ("APS") and The Stepping Stones Group LLC ("TSSG") successor-in-interest to Cobb Pediatric Speech Services, LLC dba: The Stepping Stones Group ("Contractor") to Contract No. 45FY20-10 dated January 4, 2021, by and between APS and the Contractor (the "Contract") is effective the date the APS Director/Procurement Agent executes the Amendment.

Whereas, APS and Contractor entered into the Contract for the provision of Nursing Services (RN and LPN), for an Initial Contract Term commencing on January 4, 2021 and ending on January 31, 2022.

Whereas the consent letter dated January 2021, TSSG notified APS that it had purchased the assets of the Contractor and expressed its desire to assume the rights, duties and obligations of the Contractor under the Contract effective on or about December 31, 2020.

Now therefore, in consideration of the mutual benefits, rights and obligations derived from the Contract, APS and TSSG hereby agree to amend and reaffirm the Contract as follows:

- 1. TSSG as the successor-in-interest to the Contractor hereby assumed all of the rights, duties and obligation and responsibilities of the Contractor, to include those as agreed upon in Attachment E Contractor Certification Regarding Criminal Convisions and Attachment H Student Data Usage and Privacy Agreement.
- 2. The term "Contractor" throughout the Contract shall now be deemed to mean TSSG.
- 3. Section 13. Notices shall be amended as follows:
