Evidence of having met one of the above criteria, list of subjects to be studied, along with the Notice will be provided to the school division by **August 15** of each year, as prescribed in § 22.1-254.1 of the *Code of Virginia*. If I begin home instruction after the school year has started, I will submit this NOI as soon as practicable and comply with to the other requirements within 30 day of this NOI with the school division. I understand that by **August 1** following this school year, I must **provide evidence** of educational achievement for each child listed above between the age of six (on or before September 30 of this school year) and 18 who has not graduated or obtained a high school diploma as prescribed in § 22.1-254.1 of the *Code of Virginia*.

High school-aged home instruction students may participate in Advanced Placement (AP) and Preliminary SAT/National Merit Scholarship Qualifying Test (PSAT/NMSQT), and Pre-ACT examinations. Please contact the guidance department at the high school which services your home address to register your child by **September 15** for the PSAT and **March 1** for AP test registration. Financial assistance is available to eligible students to take these examinations.
