



## Births in Projections: Trends and Forecasts

- Actual births to Arlington County parents have been declining since 2017
- Arlington Co. Govt. (ACG) revised their 2022 birth forecast; it is now lower than the 2021 births forecast
- Births trends impact enrollment projections; declining births will reduce enrollment in long-term projections



# Sept. 30 Enrollment: Grade Progression Factors

- Comparing Sept. 30, 2021 and 2022 student counts by grades: Seven (7) grades had notable year-overyear changes in enrollment trend
- These changes in trend affect Cohort Transition Rates\* used to graduate students from one grade to another grade in the projections





## **10-Year Projections in Context**


• The Fall 2022 projections anticipate more modest growth compared to prior projections



## Background





Student Success

Funds were approved in the School Board's FY23 budget for virtual tutoring services.

Throughout the 2022-23 school year APS has used *Paper* to provide virtual on-demand academic tutoring support for all students in Grades 6 –12. The service was offered at no charge to students and families.

Students receive unlimited 24/7 one-on-one support with assignments, writing feedback and studying support for all subjects, delivered by a live tutor through *Paper's* platform.

All Paper tutors are employees of the company who are trained in the Socratic teaching method to ensure consistency and high-quality service to every student.

# How does Paper support students?

Building advanced skills and encouraging self-advocacy

- Individualized homework help
- Communication skills
- Problem solving
- Multi-step word problems
- Strengthen writing skills

### Implementation of Paper in APS



- Launched during August pre-service week with all teachers of Grades 6-12
- Social Media campaign with School and Community Relations
- Regular communication with teachers to promote use with students
- Parent/guardian engagement at Back-to-School nights for Middle School & High School
- Intentional outreach to staff groups:
  - Instructional Lead Teachers
  - Directors of Counseling
  - Instructional Technology Coordinators
  - Student Support Coordinators
  - Bilingual Family Specialists
- Engagement with community stakeholders:
  - Advisory Council of Teaching and Learning
  - County Council of PTAs



## Paper Usage by APS Secondary Students




- 23% of APS students in Grades 6 12 have engaged with *Paper*.
  - Middle School: 28% of students in Grades 6 8
  - High School: 19% of students in Grades 9 12
- Usage is defined by engagement in a "Learning Activity."
- "Learning Activity" is defined as a "Live Help" session or a submission to "Review Center."
- Average "Live Help" session is 30 minutes with 1:1 support



### **Grade Level Paper Usage: Year-to-Date**



### Monthly Usage (August 2022 – February 2023)







# Student Success

#### **Current Contract Details:**

- The 12-month contract with *Paper* provides access from August 29, 2022 August 20, 2023.
- Total Contract Cost: \$602,715
  - Monthly Price/student: \$3.79
  - Annual Price/student: \$45.48
- While the cost per student is fixed, after examining the actual usage of *Paper*, the cost per participant was approximately \$190/student.




## **Options for Future Use**

 The FY 2024 budget does not include funding to continue Paper next year

- To continue virtual tutoring services in FY 2024, we provide the following options for consideration:
  - Continue implementation across all middle and high school sites for the 2023-24 school year to increase usage and monitor impact (cost: TBD)
  - Modify licenses to account for students in Grades 7-10 only (cost: TBD)
  - Establish a new contract with another vendor (cost: TBD)
