Updates on Last Year's Recommendations

ELA Office presentation

Goal is to embed writing tasks into ELA curriculum documents.

- Elementary ELA- has enhanced the K-2 CKLA student workbooks so they contain structured strategies (using the Hochman Method which has been used effectively by our new Elementary Literacy Coach).
- Secondary ELA middle school students have to complete writing tasks. This has also been embedded into the ELA curriculum.
- Pending teacher training, how to provide feedback to students, share exemplars of sample writing

Question: how to address the need to craft different writing genres? Concern:

- scoring by AI, Paper Tutoring and alternative methods to increase feedback to students - ELA is training teachers to use these so feedback can be received in 2-4 hours (students submit their writing via Canvas) rather than turn something in and get delayed feedback
 - ELAAC we need substantive feedback by a teacher
 - ELAAC asks- could we request smaller class sizes?

- ELAAC points out- non-ELA teachers need to use these feedback functions
- "More of the same" → not short writing assignments but longer, deeper literary analysis
 - ELA response: if we are working on the same assignment we won't be able to cover as many genres
 - Expectation by senior year is 8-10 pages
- Could we offer students choice between narrative and another genre?
 - o ELA response: might be possible
 - ELAAC- could we integrate narrative with expository writing?
 Research papers often tell a story then offer research.
 - ELAAC proposes- could we focus different grade levels on different genres? Might be an option to weave these together.
 - ELAAC suggests what about fewer assignments and more feedback? Fewer and higher quality.
 - ELAAC asks- is there an expectation of the number of assignments to be completed?

Assessments: New Reading Screener (Secondary); New Integrated SOL

- "IRW" announced in July 2023 -Students read social studies and science passages and write about what they read (5th, 8th, and End of Course SOLs)
 - State will use the VDOE rubric to score the IRW
 - To be scored by IA and human reader
 - These are based on current SOLs
 - State is reviewing SOLs this year
- Grade 5
 - Goal is to launch practice IRW prompts using our already existing prompts from our textbook resource CKLA

Question: Do we resubmit our recommendations?

- ELAAC advocates to support writing
 - Make sure we also underscore evaluation and assessment
 - How can we ensure that our recommendations are being implemented?
- ELAAC advocates professional learning is needed given new method of teaching writing
 - Required PD is not going to be popular with staff
- ELAAC also advocates for class reduction
- ELA suggests the consideration of literacy coaches
 - 2 for elementary (was not funded this year)
 - 2 for secondary (was not funded this year)
 - To consider writing coaches that handle cross curricular content training
 - ELAAC suggests collecting data for this year
- ELAAC asks about student portfolio
 - o ELA office has reminded staff writing has to go home
 - ELAAC asks if IRW is more rigorous than the"5 paragraph essay" from before
 - ELAAC reminds that we need to teach students how to write a good introductory paragraph, etc

In synthesis, recommendations:

- Look at results from recommendations made last year
 - Budget considerations? Due by Thanksgiving
 - Support teachers to implement new writing methodology
 - "Writing coaches" as a new position
 - Use of state colleges as a resource
 - Ex. <u>ERWC</u> = <u>University of California</u>
 - Thinking maps
 - Class size reductions

*We can submit 1-2 recommendations.

- A. "You will present and discuss your draft recommendation with the ACTL Council at one of their meetings. This is an opportunity to field test the recommendation with a wider group of school representatives and hone your rationale. If your recommendation will be related to changes to the Program of Studies (eg, middle school intensified courses) or has a budget request (eg, adding staff), you should aim to finalize that recommendation in December and present it to the School Board at the January 9, 2024 work session."
 - 1. Nov, Dec, Jan ACTL meetings: Subcommittees discuss recommendations with ACTL.
 - 2. Nov 20: Subcommittees send their recommendations to their staff liaison by Nov 20.
 - 3. Dec 8 : Staff liaisons will share their responses with Sarah Putnam and Kerri Hirsch by Dec 8.
 - 4. Dec 15 : Once reviewed, staff liaisons should share their responses back with the chair by Dec 15.
 - 5. January 2, 2024: Chairs forward the complete recommendation report to Jenny by Jan 2. (This will still be labeled as a draft, to allow the subcommittee to make adjustments to the recommendations, should they wish to, after they have had their discussion with the SB. Note that if significant changes are made to a recommendation, a revised staff response may be needed. In those instances, we'll work on the timing and logistics individually.)
 - 6. January 4: Jenny sends reports to the SB office by January 4.

- 7. January 9: Committees discuss their recommendations at SB work session.
