Recommendation to the APS School Board
February 27, 2024

Recommendation: Provide a 1.0 FTE Career and Technical Education testing coordinator to provide state-approved credentialing support to teachers and students.

Background: Career and Technical Education (CTE) credentials, licensure and occupational assessments are industry recognized, and securing these certifications demonstrate a student's workforce readiness. Offering credentialing opportunities to students is state-mandated, helps fulfill a graduation requirement, and contributes to the accreditation of high schools as part of VDOE's College, Career and Civic Readiness Index (CCCRI).

APS currently has a 0.5 FTE CTE testing coordinator. The testing coordinator organizes, manages, and implements more than fifty different industry recognized certifications, state licensure examinations, and national occupational competency assessments. There are a variety of testing organizations, each with distinct protocols for accommodations for our students with disabilities and English Learner students. The CTE testing coordinator is responsible for helping secure such accommodations.

Need:

1. **Staffing to Support Increases in Students Earned Industry-Recognized Credentials.** Currently, the 0.5 FTE CTE testing coordinator is funded by a grant that will expire at the end of this school year. Between 2020-21 and 2022-23, the number of students earning certifications has steadily increased from 2,581 to 3,133. (See Appendices B and C for detailed credentialing data.) Without a CTE testing coordinator, the implementation of providing industry-recognized credentialing exams and the ability to support teachers and students equitably will be tremendously impacted.
2. **Reduce Student Performance Gaps.** While overall pass rates have increased, there is still a significant performance gap for Hispanic, Black, English Learners and students with disabilities on industry credentials. The CTE testing coordinator position is designed to support teachers with pre-test assessment data analysis and testing resources to improve student performance on passing the certification exams in addition to overseeing the administration of exams.

Solution: APS needs a CTE testing coordinator in order to continue to provide students with robust opportunities for industry-recognized certifications, licensures and occupational assessments. This position is a critical component for the training of staff, data reporting, testing coordination, maintaining test security, and administering tests in accordance with the Virginia Department of Education and the Office of Career and Technical Education accountability and reporting requirements.

Budgetary Implications and/or Implementation Needs: The cost of a CTE testing coordinator would be \$129,474.17 salary and benefits.

Strategic Plan Alignment:

Core Values: Excellence, Equity, Collaboration

Goals:

Student Success - The CTE testing coordinator will provide support to teachers as they work to increase student success on the state approved industry credentials. Regardless of whether the students enter college or move directly into their careers, these certifications are in-demand by industry and make these students more competitive in the workforce directly after high school. This ties directly to the strategic goal of student success.

Engaged Workforce - The CTE Testing coordinator will prioritize the creation of support materials tailored specifically for teachers, enhancing their ability to facilitate industry credential attainment.

Strategies: Provide learning opportunities in a variety of settings, times, and formats that align with students' knowledge, skills, and personal interests. These work-based learning experiences such as internships and externships support student success in chosen career pathways and higher education pursuits.

Committee vote: # 11 in favor, # 0 opposed

Staff response: The staff is in favor of this proposal. Over the last three years, the position in question has been financially supported by the Perkins grant. However, with the Perkins funding set to expire at the end of this year, securing school system funds is crucial to sustain the positive impact and accomplishments achieved through this role. Notably, there has been a consistent upward trend in the number of credentialing tests taken and successfully passed in the three years since the inception of this position. Therefore, it is imperative to ensure ongoing funding to uphold and further enhance the successful outcomes associated with this role.

Essential Job Duties and Responsibilities

- Organizing, managing, and implementing of all career and technical education industry credentials, and standardized testing within the building; including training of staff, maintaining accurate and complete records, coordinating distribution and collection of secure test materials, administering tests in accordance with the established test calendar, providing and completing all test documentation and reporting to the Department of Instruction and the Office of Career and Technical Education;
- Possession of substantive analytical, technical, and organizational skills, and the ability to oversee/supervise the effective implementation of required Career and Technical Education state approved assessments and local assessments;
- Be able to provide training to school staff in using formative and summative assessments to enhance and engage student learning as well as facilitate the administration of state mandated assessments;
- Analyze multiple assessment data sources in support of the data driven decision-making efforts of school leadership;
- Monitoring student performance through the use of pre and post assessment data;
- Interpreting test results and provide written interpretation and analysis for school and individual teacher use;
- Analyzing assessment data to assist teachers with intervention to improve students' performance
- Generating data reports to assist school leaders in making informed decisions.
- Certifying that ethical test administration practices within the school building, and providing training to staff on ethical testing, test security, and data reporting procedures; and will certify and oversee ethical testing practices for all test administrations;
- Providing teachers and instructional support staff with assistance in developing and using local assessments to better align instruction to student needs;
- Serves as the school-based testing coordinator in the implementation of state and district assessment programs

- Specialized technical experience in understanding the technical and configuration requirements of all certification exams, and State Board licenses;
- Experience in providing assessment data professional development for staff
- Ability to work in a team relationship with school administration and teachers
- Successful experience designing and providing training for test proctors and teachers on multiple career and technical education state and district assessments
- Knowledge of state and assessment providers' regulations governing test administration; test security, and data reporting policies and procedures;
