If I begin home instruction after the school year has started, I will submit this NOI as soon as practicable and comply with to the other requirements within 30 day of this NOI with the school division. I understand that by August 1 following this school year, I must provide evidence of educational achievement for each child listed above between the age of six (on or before September 30 of this school year) and 18 who has not graduated or obtained a high school diploma as prescribed in § 22.1-254.1 of the Code of Virginia.

High school-aged Home Instruction students may participate in Advanced Placement (AP) and Preliminary SAT/National Merit Scholarship Qualifying Test (PSAT/NMSQT), and Pre-ACT examinations. Please contact the guidance department at the high school which services your home address to register your child by **September 15** for the PSAT and **March 1** for AP test registration. Financial assistance is available to eligible students to take these examinations.
